Ref – PAI Group - Sustainability Policy 2024

1. Policy Aims

- 1.1 The Group aims to take a leading role in defining best sustainability practice, and will set its own appropriate and demanding standards where none exist.
- 1.2 The Group is committed to implementing the requirements of all relevant sustainability legislation and regulations and, where possible, exceeding any relevant minimum requirements.
- 1.3 The Group will manage activities over which it has control and which impact upon its various 'environments' in accordance with the principles of sustainable development.
